

# Indonesia Banking Expo 2018

## Sambutan Ketua Umum Perbanas



Assalamualaikum warahmatullah wabarakatuh,

Saat ini, transformasi keuangan telah terjadi dan terus mengubah wajah perbankan di era yang semakin digital. Seiring revolusi industri berikutnya dan munculnya usaha-usaha rintisan yang berbasis digital, perbankan diharapkan dapat lebih efisien, lebih cepat, transparan, dan lebih *customer-centric*. Batasan antara kompetisi dan kolaborasi akan berbeda dengan sebelumnya, yang saat ini kita sering dengar dengan istilah *co-opetition*.

Melalui Indonesia Banking Expo 2018 yang bertemakan "*The Next Generation of Banking in the Fourth Industrial Transformation*", Perbankan diharapkan dapat lebih terbuka dan membuka kerjasama dengan pihak lain. Pergeseran penghasilan perbankan dari pendapatan bunga ke pendapatan non bunga dan tuntutan akan inovasi dan investasi di transformasi digital merupakan langkah yang tidak bisa dihindari.

Secara umum, terdapat beberapa disrupti teknologi yang dapat merubah masa depan perbankan. Sebut saja Cloud, API, Robotic Process Automation, Artificial Intelligence, dan Blockchain. Semua disrupti ini dengan segala kelebihan dan kekurangannya kadang tampak sangat menarik. Namun perlu kita sadari bahwa dampak dari transformasi digital harus dipahami secara jelas oleh para pemangku kepentingan.

Ada banyak perubahan sosial yang didorong oleh revolusi digital, dan semua ini terus terjadi dan berlangsung cepat. Di Indonesia, hal itu bisa kita lihat dengan pesatnya pertumbuhan pengguna internet, di mana tahun 2020 diperkirakan akan mencapai 145 juta pengguna atau 53% dari jumlah penduduk. 73% dari total penggunaan internet itu diakses menggunakan mobile phone.

Sebagai dampaknya, di sisi industri keuangan, customers memiliki kecenderungan untuk melakukan transaksi melalui channel digital, menggunakan internet untuk berkomunikasi dengan customer service (contoh: Chatbot), bahkan melakukan simulasi sebelum membeli sebuah produk. Bisa dikatakan bahwa masyarakat kini membawa bank di dalam saku mereka.

Industri perbankan harus bertindak sebagai katalis dan menjadi pendorong proses dan kegiatan inovasi, baik secara external yang terkait dengan customers seperti aplikasi, produk, dan layanan, maupun secara internal seperti proses otomasi dan *data analytics*.

Kalau kita dalami lebih lanjut, transformasi ini sangat bermanfaat baik bagi masyarakat maupun bank. Masyarakat dapat melakukan transaksi tanpa perlu ke cabang atau atm sehingga dapat menghemat biaya transaksi. Di sisi lain, bank juga diuntungkan karena transaksi di online channel memiliki cost yang jauh lebih rendah. Efisiensi dan efektifitas ini dalam jangka panjang diharapkan dapat memberikan dampak baik bagi industri keuangan dan pertumbuhan ekonomi.

Transformasi ini tidak akan mudah karena tentunya akan ada *challenges* dan *threats*, mulai dari isu keamanan, hingga kepatuhan dan risiko yang berhubungan dengan ekosistem keuangan digital, sementara pada saat yang sama perbankan juga harus menjawab kebutuhan masyarakat akan transformasi digital.

Kami yakin bahwa transformasi digital, transformasi industri keempat, akan membawa dampak yang sangat besar terhadap perekonomian Indonesia. Bank-bank anggota kami memahami hal ini dan bekerja keras untuk menjawab perkembangan teknologi yang sangat cepat, sementara pada saat yang sama kami juga harus mempertahankan prinsip kehati-hatian dan kepatuhan pada regulasi serta mengelola risiko-risiko terkait.

Salam sejahtera bagi kita semua!

Puji syukur kita panjatkan kepada Tuhan Yang Maha Esa, karena atas kuasa serta karunia-Nya, hari ini kita semua dapat berkumpul dalam acara Indonesia Banking Expo 2018.

Setelah event IBEX ini berlangsung dengan sukses di tahun 2017, tahun ini Indonesia Banking Expo kembali digelar dengan mengusung tema "***The Next Generation of Banking in the Fourth Industrial Transformation***".

Dalam acara IBEX 2018 ini, selain Seminar pagi ini, dimana IBEX menghadirkan narasumber internasional dan nasional di bidang keuangan, teknologi digital dan pelaku industri riil, IBEX 2018 juga akan mengadakan *Focused Group Discussion (FGD)*, dimana isu-isu yang lebih mendetil akan dibahas. Semua ide, pemikiran, dan inisiatif yang disampaikan akan kami rumuskan dalam sebuah risalah eksekutif sebagai masukan bagi Pemerintah dan regulator dalam upaya kita bersama menjawab tantangan Revolusi Industri 4.0.

Banyak poin-poin yang menarik untuk didiskusikan pada acara IBEX 2018 ini. Diantaranya pertanyaan-pertanyaan:

- Seberapa cepat bank mampu menyesuaikan diri dan ekosistemnya untuk menjawab tantangan perubahan teknologi yang sangat cepat?
- Bagaimana bentuk keterkaitan antara bank dan sektor riil nantinya? Lalu apa dampaknya terhadap pertumbuhan ekonomi dan ketenagakerjaan?
- Bagaimana format regulasi yang idealnya muncul dan apa efek dari perubahan bentuk regulasi terhadap transformasi sektor perbankan?

ini menggelitik kita semua, sebagai pelaku di industri perbankan kita wajib menjawab semua pertanyaan dan tantangan ini untuk kepentingan kita dan untuk kemaslahatan nasional.






